END-USER LICENSE AGREEMENT FOR ERITHACUS SOFTWARE

IMPORTANT-READ CAREFULLY: This Erithacus End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Erithacus Software Limited ("Erithacus") for the Erithacus software product identified above. This product includes computer software and may include associated media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, do not install or use the SOFTWARE PRODUCT; you may, however, return it to your place of purchase for a full refund.

SOFTWARE PRODUCT LICENSE

1. GRANT OF LICENSE. Erithacus grants to you as an individual a personal, nonexclusive license to make and use copies of the SOFTWARE PRODUCT in the manner provided below. If you are an entity, Erithacus grants to you the right to designate one individual within your organization, per license purchased, to have the right to use the SOFTWARE PRODUCT in the manner provided below.

Types of License. The program is sold as either as a single-user or a multi-user license. Where you have a multiple-user license then the terms below will apply to each of the designated users of the license. For a single-user license the terms below apply to a sole license holder.

Licenses restricted to non-profit organizations. The software is available at reduced cost to individuals who work for non-profit organizations; this is also referred to as "Academic licensing" or "Student licensing." You may not use software licensed for use in non-profit organizations in a commercial environment.

Usage. You may use the program on any computer you own, so long as there is no possibility of it being used at one location while it is being used at another. There is, however, a limit to the number of concurrently activated copies that are permitted and it might be necessary to deactivate the software on one computer before it can be reactivated on another. Additional licenses must be purchased for any additional user.

Copying. You may not make copies of any part of the program or documentation except for backup purposes for use on your own computer.

Transfer. You may transfer all of your rights under this EULA, provided you retain no copies, you transfer all of the SOFTWARE PRODUCT (including all component parts, the media and printed materials, any upgrades, and this EULA), you provide Erithacus notice of your name, company, and address and the name, company, and address of the person to whom you are transferring the rights granted herein, and the recipient agrees to the terms of this EULA. If the SOFTWARE PRODUCT is an upgrade, any transfer must include all prior versions of the SOFTWARE PRODUCT. In no event may you transfer, assign, rent, lease, sell or otherwise dispose of the Software on a temporary or permanent basis except as expressly provided herein.

Rental. You may not rent or lease the SOFTWARE PRODUCT.

Modification. Modify, adapt, translate, reverse engineer, decompile, disassemble, or create derivative works based on the Software. You may not modify, adapt, translate or create derivative works based on the written material without prior written consent of Erithacus.

Proprietary Notices. You may not remove any proprietary notices, labels or marks on the SOFTWARE PRODUCT.

Termination. Without prejudice to any other rights, Erithacus may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the SOFTWARE PRODUCT and all of its component parts.

2. COPYRIGHT. All title and copyrights in and to the SOFTWARE PRODUCT (including but not limited to any images, photographs, animations, video, audio, music, text, and "applets," incorporated into the SOFTWARE PRODUCT), the accompanying printed materials, and any copies of the SOFTWARE PRODUCT, are owned by Erithacus or its suppliers. The SOFTWARE PRODUCT is protected by copyright laws and international treaty provisions. Therefore, you must treat the SOFTWARE PRODUCT like any other copyrighted material except that you may either (a) make one copy of the SOFTWARE PRODUCT solely for backup or archival purposes, or (b) install the SOFTWARE PRODUCT on a single computer provided you keep the original solely for backup or archival purposes. You may not copy the printed materials accompanying the SOFTWARE PRODUCT.

DISCLAIMER OF WARRANTY

Erithacus warrants that the media containing the SOFTWARE PRODUCT, if provided by Erithacus, is free from defects in material and workmanship and will so remain for ninety (90) days from the date you acquired the Software. Erithacus's sole liability, and your sole remedy, for any breach of this warranty shall be, in Erithacus's sole discretion: (i) to replace your defective media; or (ii) if the above remedy is impracticable, to refund any License fee you paid for the Software. Replaced Software and Documentation shall be covered by this limited warranty for the period remaining under the warranty that covered the original Software, or if longer, for thirty (30) days after the date of shipment to you of the replaced Software. Only if you inform Erithacus of your problem with the Software during the applicable warranty period and provide evidence of the date you acquired the Software will Erithacus be obligated to honor this warranty. Erithacus will use reasonable commercial efforts to replace or refund pursuant to the foregoing warranty within thirty (30) days of being so notified.

ERITHACUS MAKES NO OTHER WARRANTY, REPRESENTATION, OR CONDITION, EXPRESS OR IMPLIED, AND EXPRESSLY DISCLAIMS THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NONINFRINGEMENT OF THIRD PARTY RIGHTS. If you make any modifications to the Software during the warranty period; if the media is subjected to accident, abuse, or improper use; or if you violate the terms of this Agreement, then this warranty shall immediately be terminated. This warranty shall not apply if the Software is used on or in conjunction with hardware or software other than the unmodified version of hardware and software with which the Software was designed to be used as described in the SOFTWARE PRODUCT documentation.

THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY HAVE OTHER LEGAL RIGHTS THAT VARY BY JURISDICTION.

This EULA represents the complete agreement concerning this license between the parties and supersedes all prior agreements and representations between them. This EULA may be amended only in writing executed by both parties. THE ACCEPTANCE OF ANY PURCHASE ORDER PLACED BY YOU IS EXPRESSLY MADE CONDITIONAL ON YOUR ASSENT TO THE TERMS SET FORTH HEREIN, AND NOT THOSE CONTAINED IN YOUR PURCHASE ORDER.
